Date for service of replies or answers to motions by petitioners: 4/4/2023
- Motions or requests for a more definite statement shall be filed by the respondents with the court and served on the petitioners or their counsel in accordance with Rule 6(c)(2)

Date for service by respondents of request for a more definite statement: 3/24/2023
Date for service by petitioners of an answer of more definite statement: 4/4/2023
- Court session for any motions filed per ¶¶ 1,2 *supra*: to be assigned
- Discovery by written or oral deposition or written interrogatories per Rule 8:

Date for service of all Rule 8 requests: 4/12/2023
Date due for answers to all Rule 8 requests: 4/26/2023

The parties shall provide to each other and the court not later than sixty (60) days prior to trial a list of all the witnesses expected to testify at trial, including the name, phone number, address, and electronic address of each witness; and copies of all documents and exhibits intended for use at trial.
8. Trial of the case per Rule 11: to be assigned
9. Post-trial motions and other submissions: 15 days after trial

All parties and their counsel shall file and serve all documents pursuant to the above schedule, and shall serve the court with proof of service of all documents served. Service of all documents upon the court and other parties or counsel may be by regular mail with a sworn affidavit of service by mailing, fax with a sworn affidavit of service by fax, or by e-mail with a sworn affidavit of service by e-mail. Any party may request an extension of time in which to file or complete any of the above matters upon request made to the court.
